# INTRODUCTION

The Colombian Institute of Family Welfare (ICBF) is honored to invite the 32 Member States of the Organization of American States (OAS), international organizations, civil society, and the children and adolescents of the Americas to the Fifth Inter-American Forum on Systems for the Promotion and Protection of the Rights of Children and Adolescents, to be held on 25 and 26 September, 2025, in Bogotá, Colombia, at the Tequendama Hotel.

This forum aims to be a regional space for dialogue, coordination, and collective construction around the progress, challenges, and opportunities to consolidate comprehensive systems that guarantee the rights of children and adolescents in the Americas. Through the exchange of experiences and good practices among governments, institutions, civil society, communities, and—most importantly—children and adolescents as key actors, the aim is to strengthen protection frameworks with a focus on rights, inclusion, participation, and differential approaches.

The Fifth Inter-American Forum on Systems for the Promotion and Protection of the Rights of Children and Adolescents will serve as a meeting point to move toward a more just, inclusive, and protective Americas for the rights of its children and adolescents.



# Colombian Institute of Family Welfare (ICBF)

The Colombian Institute of Family Welfare (ICBF) is the entity responsible for the prevention and comprehensive protection of early childhood, childhood, and adolescence, as well as for strengthening youth and families in Colombia. Since its creation in 1968, the ICBF has been a pillar of the country's social development, leading comprehensive actions for care, protection, prevention, and the promotion of rights in coordination with different actors from the State, civil society, and international cooperation.

As the governing body of the National Family Welfare System (SNBF), the ICBF promotes comprehensive responses under a rights-based, differential, territorial, and intersectional approach that acknowledges the diversity of situations and contexts in which children and adolescents live. The institution coordinates and implements care modalities in prevention and protection throughout the national territory, reaching urban, rural, dispersed rural areas, and ethnic communities, with a presence through 33 regional offices and 218 zonal centers.

The ICBF provides services through two main approaches: promotion and protection, especially for children and adolescents facing threats or violations of their rights, thereby impacting its mission structure across the life course, as follows:

## Promotion of Rights:

- **Early Childhood:** Its mission is to guarantee the rights and integral development of children from gestation to 5 years of age, with actions focused on sensitive caregiving, early education, health, nutrition, protection, and participation. Its work is grounded in a deep knowledge of public policies and current regulations, which enables it to act with quality and responsibility throughout the country.
- **Childhood and Adolescence:** Contributes to the integral development of children and adolescents aged 6 to 18 years through the recognition and promotion of rights, as



well as the prevention of violations, fostering protective environments and opportunities for developing life projects under the principle of shared responsibility among the family, society, and the State.

- **Families and Communities:** Leads the implementation of policies, plans, programs, and projects to strengthen ties and the capacities for agency, care, and parenting within families, communities, and territories, in order to promote the comprehensive protection of the rights of children, adolescents and families, from an intercultural and inclusive perspective.
- **Nutrition:** Works to prevent malnutrition among pregnant and breastfeeding women, as well as among children under five years of age.

## Protection:

- **Protection:** As its name suggests, it seeks to guarantee comprehensive protection for children and adolescents who have suffered threats or violations of their rights, as well as adolescents and young people in conflict with the law, with the aim of restoring their rights so that they can overcome physical, social, emotional and psychological damage, develop their life plans and grow up in protective environments. It operates through three sub-directorates: Restitution of Rights, Criminal Responsibility of Adolescents and Adoptions, in addition to the Coordination of Administrative Authorities, which provides technical guidance to administrative authorities



# I. General Information about Colombia

**Capital:** Bogotá D.C.

**President:** Gustavo Francisco Petro Urrego (2022–2026).

## Political system and institutional structure

Colombia is a unitary republic with a presidential system and a participatory, pluralist democracy. The 1991 Political Constitution recognizes popular sovereignty, the separation of powers, and a broad catalog of fundamental rights. The country is territorially organized into 32 departments and one capital district (Bogotá), with a decentralized model that grants administrative powers to governorates and municipalities.

The Colombian State is composed of three branches of public power:

- **Executive:** Administers the State under the leadership of the President of the Republic.
- **Legislative:** Represented by Congress, which is divided into the Senate and the House of Representatives; it is responsible for creating, amending, and approving laws.
- **Judicial:** composed of multiple high courts, each within its respective jurisdiction, such as the Supreme Court of Justice, the Council of State, the Superior Council of the Judiciary, and the Constitutional Court. Additionally, within the framework of the 2016 Peace Agreement, the Special Jurisdiction for Peace (JEP) was created.

## Colombia's role in the regional and international arena

Colombia is an active member of multiple multilateral organizations, including the OAS, UN, CAN, Pacific Alliance, and OECD, and plays a leading role in promoting human rights, South-South cooperation, and sustainable development.

In recent years, the country has gained international recognition for its commitment to the transition to peace, the fight against climate change, biodiversity protection, and the promotion of the rights of children, youth, and ethnic communities, with special emphasis on preventing violence against children and adolescents.

As a result, in 2024, Colombia hosted the 16th Conference of the Parties to the Convention on Biological Diversity (COP16), an event attended by delegations from more than 190

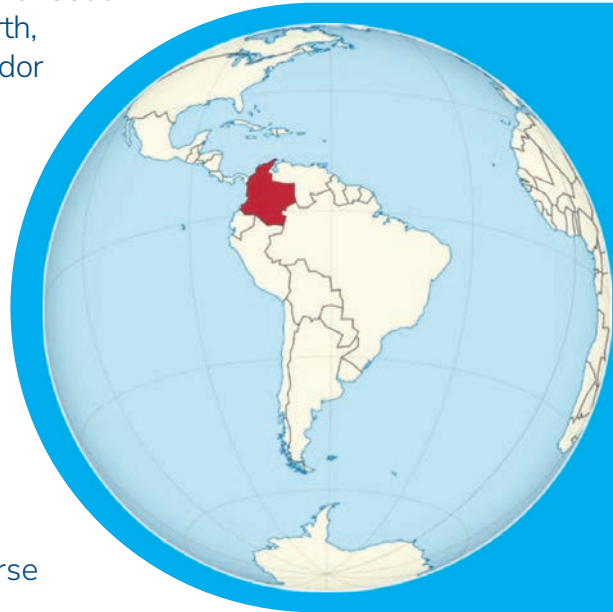


countries. A similar number of countries also participated in the First World Ministerial Conference to End Violence Against Children and Adolescents.

## Geographic location

Colombia is located in the north- western corner of South America. It borders the Caribbean Sea to the north, Venezuela and Brazil to the east, Peru and Ecuador to the south, and Panama and the Pacific Ocean to the west. Its privileged location provides access to two oceans and a great diversity of ecosystems, making it one of the most biodiverse countries in the world.

Colombia has six natural regions: Caribbean, Pacific, Andean, Orinoquía, Insular and Amazonian, each with unique geographic, climatic, and cultural characteristics. The Andes Mountain range crosses the country, generating a variety of altitudinal zones that allow for rich agricultural production and diverse landscapes.



## Climate

Colombia benefits from a privileged location on the equatorial line, which provides it with a tropical and stable climate throughout the year, without marked seasons. However, due to its geographic and altitudinal diversity, the country presents a wide variety of climates, ranging from hot and humid in the coastal and Amazon regions to cold mountain climates in the Andes.

The city of Bogotá, the country's capital and the host of the Fifth Inter-American Forum, is located 2,640 meters above sea level and has a temperate mountain climate, with average temperatures ranging between 9°C and 20°C. Cloudy skies, intermittent rain, and weather changes throughout the day are common. Visitors are advised to bring warm clothing and light waterproof.

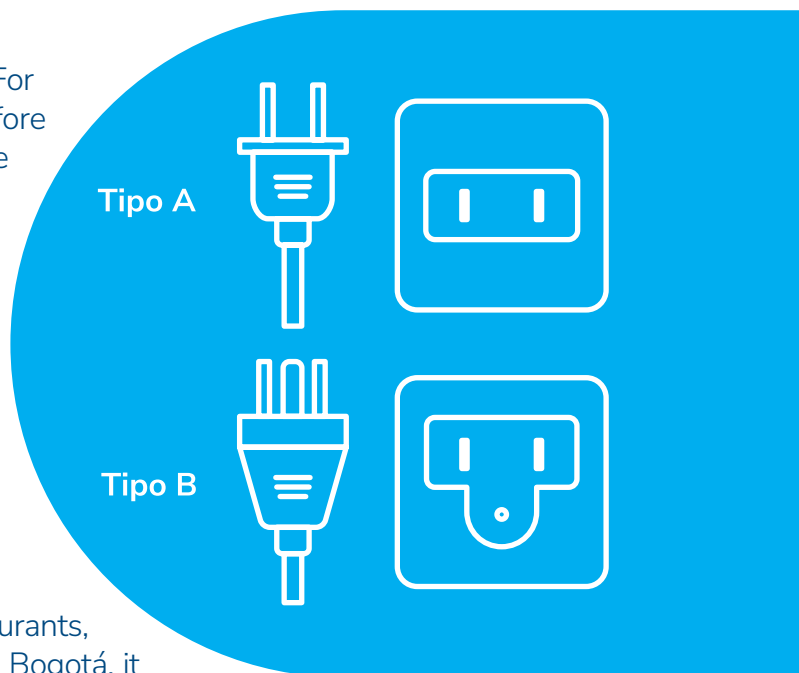
## Useful Information

- **Official language:** The official language of Colombia is Spanish. In some indigenous and Afro-Colombian territories, native languages and creoles are also spoken and are recognized as official languages within their regions.
- **Currency:** The legal tender is the Colombian peso (COP). Banknotes are issued in



denominations of 2,000, 5,000, 10,000, 20,000, 50,000, and 100,000 pesos, and coins of 50, 100, 200, 500, and 1,000 pesos. Card payments are accepted in most hotels, restaurants, and shops, although it is recommended to carry cash for minor expenses.

- **Time zone:** Colombia operates under GMT-5, with no daylight savings time. The time remains the same throughout the year.
- **Telephone code:** The country code is +57. For domestic calls, the number “60” is added before the city or regional code; for Bogotá, the code is “1.” For example, to call Bogotá, dial +57 601 followed by the local number.
- **Electricity:** Electricity in Colombia is 110 volts and 60 Hz. Outlets are type A and B, the same as those used in the United States and Canada. Visitors from other regions are advised to check device compatibility and bring plug adapters if necessary.
- **Internet and Connectivity:** Most hotels, restaurants, and event venues offer free Wi-Fi access. In Bogotá, it is possible to purchase prepaid SIM cards or low-cost mobile data plans from providers such as Claro, Movistar, Tigo, and WOM.



## Airport Tax for International Visitors

In Colombia, international passengers must pay an airport tax, which is generally included in the total price of the airline ticket. For flights entering or leaving the country, this fee is approximately USD 38 to 45, depending on the airport and airline. No additional payments are required at the airport, except in exceptional cases. Travelers are advised to confirm with their airline that the tax has been included at the time of purchase.

## Tipping in Colombia

In Colombia, tipping is not mandatory, but it is a common practice as a gesture of appreciation for good service. In restaurants and café store 10% tip is usually suggested, included as a “voluntary tip” on the bill; customers may decide whether to pay it or not. In hotels, it is customary to leave a tip for housekeeping staff and bellboys (around COP 5,000–10,000 per service). In taxis and transportation services, tipping is not expected, although rounding up the fare or leaving a small extra amount is appreciated.



## Credit Cards and Payment Methods

Most commercial establishments, restaurants, hotels, and services in Colombia accept international credit and debit cards (Visa, MasterCard, American Express, and Diners Club). Digital payment systems such as Apple Pay, Google Pay, and local e-wallets can also be used. However, it is recommended to carry some cash in Colombian pesos for small purchases, public transportation, or in places that do not accept cards, such as small shops.



## II. Visas and Entry Requirements to the Country

Within the framework of the Fifth Inter-American Forum on Systems for the Promotion and Comprehensive Protection of the Rights of Children and Adolescents, it is informed that, in accordance with Resolutions 5488 of 2022 and 3717 of 2023, nationals of OAS Member States do not require a visa to enter Colombia, with the exception of Haiti and Nicaragua. Individuals from these countries, as well as those from nationalities not exempt from visa requirements, must apply for a Type V – Events Visa individually and virtually through the website of the Colombian Ministry of Foreign Affairs: [https://www.cancilleria.gov.co/tramites\\_servicios/visa](https://www.cancilleria.gov.co/tramites_servicios/visa)

The procedure requires completing the corresponding form and selecting the Colombian consulate according to the applicant's country of nationality or legal residence. In addition, documents must be submitted such as: a recent photograph, a copy of the biographical page of the passport with a minimum validity of six months, an invitation letter signed by the entity organizing the event in Colombia, and a letter of support from the organization the participant represents.

In the case of minors, additional documents must be attached, including the birth certificate translated and apostilled, a visa application signed by the parents or legal guardians, and the valid visa of the responsible adult in Colombia, among other requirements.

If a visa is required, it must be reported so that the ICBF may complement the process with the Ministry of Foreign Affairs, while the delegate simultaneously carries out the procedure at the respective consulate. It is necessary to send us the application with the following information: full names, nationality, passport number and place of residence, identification of minors and their guardians, as well as commitments regarding expense coverage and return to the country of origin.

It should be noted that this documentation does not replace the individual visa application nor guarantee its approval. The review and decision of each application rests exclusively



with the consulates, which may request additional information.

## Vaccination requirements

Currently, Colombia does not require COVID-19 vaccination certificates or PCR tests for entry into the country; however, travelers are advised to be up to date with their basic vaccination schedule, especially against preventable diseases such as measles, rubella, yellow fever, tetanus, and hepatitis A and B, according to WHO recommendations for international travelers. For those planning to visit rural, jungle, or tropical climate regions outside Bogotá, the yellow fever vaccine is recommended, especially if traveling to areas such as the Amazon, the Caribbean, or the eastern part of the country. The vaccination must be administered at least 10 days before the trip. In Bogotá and other urban areas, no specific vaccination is mandatory for entry. Travelers are advised to carry their international vaccination card, especially if making stopovers in other countries where it is required.



## III. Event Location

The event venue is the Tequendama Hotel, located in the San Diego neighborhood, in the heart of Bogotá's international and financial center, at Carrera 10 #26-21. This recently renovated hotel offers services such as high-quality accommodation, restaurants (El Virrey and Piazza Roma), Café Vienés, a spa with Turkish bath and sauna, a gym, free Wi-Fi, and covered parking, in addition to extensive facilities, event halls, and easy access to strategic points of the capital.



It is recognized as an iconic building and has been declared a Cultural Heritage Site for its historical and architectural significance. It features modern facilities and areas for business events and leisure. The hotel's location is strategic, as it is very close to La Santamaría Cultural Plaza, the National Museum, the District Planetarium, the National Park, and the city's historic center.

## IV. Accommodation

The Fifth Inter-American Forum on Systems for the Promotion and Comprehensive Protection of the Rights of Children and Adolescents will take place in Bogotá, Colombia, with the emblematic Tequendama Hotel Bogotá, located in the city center at Carrera 10 #26-21, as the main venue, offering high-quality lodging options.

## V. Transportation

Transportation Airport–hotel (Tequendama and suggested hotels)–airport transfers for delegations will be included as part of the event’s logistics and organization. It is therefore important that you confirm your participation and itinerary so that the appropriate planning can be carried out.

El Dorado International Airport, Colombia’s main airport, operates 24 hours a day and has an exclusive parking area for authorized taxis near both the international and domestic terminals.

Authorized taxis are located on the first floor, lane number 1, in front of exits 2 and 5 of Terminal 1. There are also digital kiosks (totems) located in front of the baggage claim areas to pre-calculate the fare and pay by card before boarding the vehicle.

A typical fare from El Dorado to downtown Bogotá ranges between COP 35,000 and COP 45,000, which is equivalent to approximately USD 8 to USD 12 depending on the exchange rate at the time of arrival; the final cost may also vary depending on traffic and the exact destination.

There is also the option of hiring private transportation services (Uber, Cabify, Yango).

### Recommendations for visitors

- Use only authorized taxis from the designated airport lanes; avoid private vehicles or taxis outside these modules to ensure safety.
- Always check that the vehicle displays its control card, that the taximeter is functioning, and verify online (via the El Dorado app or website) that it is registered as authorized.

## VII. Places of Interest

### La Candelaria

Located in the heart of the capital, La Candelaria is considered one of the favorite areas for residents and visitors alike, thanks to its historical value and captivating colonial style. This characteristic district is the birthplace of the city, witness to historical milestones of the country, and a setting where the heritage of the Muisca people, who inhabited the area thousands of years before the Spanish conquest, still prevails between the departments of Cundinamarca and Boyacá. Much of its heritage value is due to its strategic location and the importance of the surrounding buildings such as the emblematic Plaza de Bolívar, the Primatial Cathedral of Colombia, the National Capitol, the Liévano Palace (seat of Bogotá's City Hall), and the Palace of Justice. <https://goo su/StGUr>



### Bogotá Planetarium and Space Museum

Located at Calle 26B No. 5-93, just a 5-minute walk from the hotel, this interactive complex offers exhibitions on astronomy, family workshops, and a planetarium dome.

## Casa de Bolívar Museum

This house-museum was the residence of Simón Bolívar, the great South American liberator, during much of his stay in the city. It is noteworthy that the house served as Bolívar's residence during his stays in Bogotá between 1820 and 1830, after liberating much of South America from Spanish rule. Bolívar, considered one of the most important figures in the history of Latin America, spent time here reflecting on the political challenges facing the new independent republics.

**Schedule:** Tuesday to Sunday, 9:00 a.m. – 5:00 p.m. Open to the public.

**Foreign visitors (USD):** Children 6–12 years, USD 5; youth and adults 13–59 years, USD 10; children under 5 and seniors, free.



## National Museum of Colombia

Located at Carrera 7 No. 28-66, about 8-minute walk from the hotel.

It exhibits Colombian art, history, archaeology, and cultural heritage.

**Schedule and admission:** General entry approximately USD 10 for foreigners; reduced fare of USD 5 for minors and students; free entry on certain days.. <https://goo.su/tZzleQf>



## Gold Museum

12-minute walk away, located at Carrera 6 No. 15-88.

It houses the world's largest collection of pre-Hispanic indigenous goldsmithing from the pre-Columbian cultures of present-day Colombia. The collection includes more than 34,000 gold pieces and 20,000 stone, ceramic, textile, and other artifacts.

**Schedule and admission:** Tuesday to Saturday, 9:00 a.m. – 7:00 p.m.; Sundays, 10:00 a.m. – 5:00 p.m. Admission COP 5,000. Audio guide rental COP 8,000.

## Bogotá Museum of Modern Art – MAMBO

Located at Calle 24 No. 6-00, about 8–10 minute walk from the Tequendama Hotel, this is a key cultural center in the city. It houses a collection of around 3,633 works of modern and contemporary art.

**Schedule and admission:** Tuesday to Saturday, 10:00 a.m. – 6:00 p.m.; Sundays and holidays, 12:00 p.m. – 5:00 p.m. General public (foreign visitors): COP 25,000, approximately USD 6.25 (at an exchange rate of ~4,000 COP/USD). Children under 5 and persons with disabilities enter free.
